### 17. Discussion with Nielsen Ranches regarding proposed PID

Shaun Johnson stood for this item. Benj Becker and George Rowley were also present via Zoom. Councilmember Hutchins asked if there was anything out of the ordinary on this PID procedure. The proposed numbers were 20 PIDs and 8 MILs, but have lowered the number to 16 PIDs and 6.5 MILs. There was discussion about some additional concerns that need to be addressed. Alex Buxton, attorney to the
