5. Consideration of Ordinance 2023-04 Approving Amending Grantsville City Code 5-1-15 To Require Compaction Reports

Councilmember Jenkins asked if this required for building. City Manager, Jesse Wilson, advised this is required more for the homes being built. Councilmember Jenkins asked if the report comes from the City or if it comes from a third party. Mr. Wilson advised it would come from a third party. Councilmember Jenkins asked if this would be a large expense for a home owner. Councilmember Hutchins advised it would be over \$1,000.00. City Engineer, Dan England, explained the process around compaction for the foundation of a home. Mr. England advised it would make a big impact for home owners.

10. Discussion with Veterans Memorial Committee regarding location of Veterans Memorial

Whit Cook was present for this item. Mr. Cook explained the Committee would like to use the park next to the fire station. Mr. Cook explained the committee is in charge of raising money and design. Councilmember Allen asked how the Fire Department felt about using the space surrounding the fire station. Mr. Cook advised Fire Chief Daniels is on the committee and supports this location. Mayor Critchlow advised he wants the name to say "Academy Square Veteran's Memorial Park". Mr. Cook advised the committee would like to honor the old school house and moving the gazebo to Cherry Street. Councilmember Allen asked if the park can be Veterans Memorial Park at Academy Square. Councilmember Jenkins advised she loves the location and would like this to be a catalyst for improving "Downtown Main Street". Councilmember Hutchins said for it to be a proper memorial for Veterans, it should not have more than one name. Councilmember Rowberry asked about cost. Mr. Cook advised they have a study and the cost came in around \$670,000. Mr. Cook would like assistance with name submissions for the wall. Mr. Cook advised the kick off event will be on Memorial Day. Mr. Cook advised the committee would like to have a booth at all City events. Councilmember Bevan asked if there was a Federal grant that could assist with the funding. Mr. Cook advised mostly the grants come from the State and County.

11. Discussion regarding Grantsville City Justice Court

Mayor Critchlow advised there is a meeting next Thursday with the County Manager to determine what to do with the Court. Councilmember Hutchins advised he recognizes the distribution cannot be changed but the City needs to determine what is best for the residents as it does cost the community money. Mayor Critchlow advised they will discuss with the County if other municipalities want to be part of the Grantsville City Justice Court.
